#### e. Round 28

i. There is \$13 million available to support agricultural water quality conservation projects across the State. The Agricultural Nonpoint program awards projects that focus on either environmental planning or the implementation of best management practice systems to protect New York's watersheds. Projects include conservation measures, such as nutrient management through manure storage, vegetative buffers along streams, and conservation cover crops. Deadline is May 2, 2022.

### f. Climate Resilient Farming Grant Program -

i. This grant helps farms reduce their operational impact on the environment and address the impacts of extreme weather events resulting from climate change. There is \$8 million in funding for this sixth round. Funding is available to support agricultural projects and related equipment purchases that aim to reduce greenhouse gas emissions and help agricultural producers prepare for and better manage impacts of climate change, including increased heavy storm events, overall rainfall, and periods of drought. Deadline is March 28, 2022.
