k. Van Campen Creek -

- i. A public notice was posted for the project, this is required for 15 days. Once that is complete, FEMA will complete their review for the next phase of the project.
- Genesee River Stabilization at Belfast Phase 2 FEMA is requiring an archaeological study to be performed for this site. They are requesting we update our budget to reflect the added cost of this study.
- iii. County Road 48 Stabilization NYS Division of Homeland Security & Emergency Services is going to check with FEMA to see what the status of this application is.
- I. CAFO Waste Storage Grant
 - i. Lismore Dairy's manure storage closeout almost complete.
 - ii. Val Dale Farm working on closeout.
- m. WQIP Grants
 - i. Working on grant applications that are due July 28, 2023.
 - 1. Salt Storage Buildings Towns of Belfast, Willing and possibly New Hudson.
 - 2. Engineering Grants plan on applying for 2-3 engineering grants for streambank stabilization planning.
 - ii. The State is starting to send us contract documents for grants that we wrote a year ago. We will be submitting these documents so we can move forward with the projects.

- 2. Technical Assistance
 - a. We met with staff from the Genesee Valley Greenway State Park and the board members of the Rockville Lake Cottage Owner to look at stream erosion that is threatening Rockville Lake. There is an interest in restoring areas of the Greenway Trail that are closed due to this erosion. The Genesee Valley Greenway State Park staff are going to survey the area and work with us to develop a plan to stabilize this section of the stream.
 - b. Agricultural District No. 1 is open for its 8-year review. Ag District No. 1 is made up of land in the towns of Allen, Birdsall, Caneadea, Centerville, Granger, Hume, New Hudson and Rushford.
 - c. We are waiting for the County to decide how they want to proceed with the sale of timber on the Bennett Lot on Rattlesnake Hill.

d. We have not received anything yet from the County regarding the shared services agreement with DPW to assist with the excavator.
