5. Old Business

a. FL-LOWPA 21-22 Update – Rob Chamberlain – Project was to originally install fencing to expand the farms grazing acres for their beef cows. Due to changes on the farm, the farm is not going to do the fencing, but do some erosion control work on the same property. The farm is requesting an increase in funding from \$15,000 to \$20,500. Approved (Demick – Ormsby)

FL-LOWPA 22-23 Joe Meehan Farm Erosion Control Project is to install an erosion control system that will involve installing a riser and approximately 600' of 12" pipe to keep water from flowing across the surface of a farm field. The farm is requesting \$10,000 to complete this project. Approved (Demick Ormsby)
- b. Resolution 2024-03 AEM Year 18 Approved (Ormsby Demick)
 - 1. Lost Valley Farm Roofed Feeding area -\$100,000 Project is to install a roofed feed pad to allow the farm to feed their beef animals under roof during the winter months.
 - 2. Nickerson Farm Bedded Pack Barn \$100,000- Project is to install a bedded pack barn that will allow the farm to collect all of the manure from the beef cows during the winter months and then will apply it when the weather conditions are suitable.
