 - ii. County Road 48 Stabilization preliminary designs have been completed. We will be contacting landowners about some access concerns.

 We are completing an application for a stabilization project on the Genesee River in the Town of Caneadea. Erosion is threatening Council House Road. Applications are due June 6, 2025.

2. Stream Program

- a. Village of Cuba working on a stream permit for work on Griffith Creek.
- b. Terrance McCormick Stream Stabilization submitted a stream permit application for erosion on Dyke Creek in Andover.
- c. Town of Andover working on a stream stabilization permit application for the Town of Andover on Dyke Creek to repair damage from last August's storm.
- d. Friendship School will have estimate submitted to the school the week of May 19th.
- e. Kailbourne Stream Stabilization We are ready to start this project. Timeframe is dependent on what assistance we will be providing to landowners from the May 5th storm and the weather.
- f. Todd Philips Stream Stabilization Permit has been approved.
- g. Town of Independence continuing to assist the Town with their FEMA paperwork. The NRCS EWP funding of \$1.5 million has been put on hold. Email is included after this report.
- h. Cuba-Rushford School provided engineering assistance for flooding that was occurring at the at the school.

5. Old Business

a. Round 30 Update – There is a lot of competition for Round 30 Grant Funding. Almost \$81 Million Dollars in funding was requested with only \$25 Million Dollars of funding available. The ranked list should be approved at the June State Committee meeting.

6. New Business

a. Update to Air Conditioning System – The Board room and two of the office spaces in the building do not have air conditioning. We are looking to get a quote at

- possibly putting in mini splits, or updating the current system. Scott will update everyone when he gets more information.
- b. State Budget Update The 2025-2026 budget for the Environmental Protection Fund (EPF) has been approved. This year the budget was increased from \$400 million to \$425 Million.
- c. AEM Year 19 They have changed the program from a 2 year program to a 3 year program. We will be applying for Option C, as Scott is a CNMP Certified Planner, Leonard is a state Licensed Professional Engineer and Emily J is Certified Forester. Option C is increasing from \$260K to \$420K. There is also another \$300 for projects over those 3 years. They have upped the hourly rates they are paying us based on certifications also.
